Insurance for such loss, damages, or injury shall be the sole responsibility of each exhibitor at his/her own cost.
3. I hereby agree and acknowledge that I will hold harmless The Art & Craft Guild and/or City of Parrottsville, its members, board, and volunteers and assigns from any and all person of whatever nature arising out of any incident or event occurring at the location rented by me during this event.

7. Each vendor is responsible for their taxes.
